SUSAN G. KOMEN SAN DIEGO 3-DAY FUNDRAISING MATCH CHALLENGE

From October 28 -29, 2025 the first 2,475 registered Komen 2025 San Diego 3-Day participants (3-Day, 2-Day, 1-Day Walker or Crew Member) that fundraise at least \$100 will receive a fundraising boost of \$100.

All donations must be made through the participant's fundraising page or connected to Facebook Fundraiser to be counted for this incentive. Only checks entered using the event mobile app will be eligible to be counted for this incentive. Cash donations entered using the participant center or mobile app are not eligible/will not be counted.

Beth Byrne, a generous donor, has provided Susan G. Komen with up to \$247,500 to support this fundraising boost.

Self-donations will count towards the fundraising challenge. The fundraising boost will be distributed directly into the winners' fundraising page within two weeks after the end of the incentive period. Limit one fundraising boost per participant. Susan G. Komen reserves the right to modify or cancel at any time without prior notice.

Official Contest Rules

ELIGIBILITY: Contest is open to legal residents of the United States who are 18 years of age or older at the time of entry. Employees of Susan G. Komen ("Sponsor") and its respective officers, directors, parents, subsidiaries, affiliates, as well as their immediate family members, are not eligible to enter or win. Entrants may need to provide proof of residency. All entries should be submitted in good faith.

Void where prohibited by law. This contest is subject to all applicable federal, state, and local laws.

HOW TO ENTER: Contest period begins on October 28, 2025 at 12:01AM CST and will end on October 29, 2025 at 11:59PM CST.

When you fully complete the following actions during the Contest period, you are competing with others to win a prize.

When you are registered as a 2025 Komen 3-Day San Diego 3-Day Walker, (3-Day, 2-Day or 1-Day Walker) or Crew Member on the event website you will be automatically considered for this contest.

Sponsor will track online fundraising efforts during the contest period via:

- 1. Susan G. Komen 3-Day website
- 2. 3-Day app mobile check deposit, and
- 3. Facebook Fundraiser

Only the listed online platforms directly connected with the entrants' 3-Day Participant Center will be eligible. Self-donations will count towards the fundraising challenge.

Offline donations, including matching gifts and mailed donations, or any other donations not registered in the 3-Day Participant Center do not qualify towards the contest. Only the first installment of a new monthly recurring gift will count towards the fundraising challenge. Donations collected via Facebook fundraiser that have not yet posted to the participant's 3-Day fundraising account do not qualify towards the contest.

After the close of the contest period, the top four (4) 2025 Komen San Diego 3-Day participants that raise the most amount of funds during the contest period will win a prize.

Beth Byrne, a generous donor, has provided Susan G. Komen with up to \$2,500 to support this fundraising challenge.

PRIZE DESCRIPTION:

First Place Top Fundraiser: A \$1,000 fundraising boost.

Second Place Second Top Fundraiser: A \$750 fundraising boost

Third Place Third Top Fundraiser: A \$500 fundraising boost.

Fourth Place Fourth Top Fundraiser: A \$250 fundraising boost.

WINNER SELECTION: All eligible entries submitted during the Contest period will be considered and the winners determined by the criteria listed in How to Enter. Four (4) winners will be awarded a prize. In the instance of a tie, the tiebreaker will be determined by the winner who raised the most amount of funds first in time. Limit one (1) prize per individual.

WINNER NOTIFICATION: The winners will be contacted by Sponsor via the email address or phone number provided in their registration. To claim the prize, the winner must accept the prize within ten (10) business days after the first notification by Sponsor. Failure to timely claim the prize will result in disqualification. If a potential winner is disqualified for any reason, Sponsor may award the applicable prize to an alternate winner based on the next in line under How to Enter. It is within the discretion of Sponsor to select an alternate winner if the prize is unclaimed/forfeited but is not required to do so. Once the prize is claimed, Sponsor will deliver deposit the fundraising boost to the winners' participants accounts within 10 business days.

Sponsor reserves the right to correct any typographical, printing, computer programming or operator errors.

Sponsor is not responsible for any entry that is lost, late, illegible, stolen, mutilated, incomplete, invalid, unintelligible, postage-due, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, human error, entries not timely received, lost or unavailable network connections, failed, incomplete or garbled computer transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsors.

Prize is awarded as is, has no cash redemption equivalent, is non-transferable and cannot be resold, traded, or auctioned. All incidental costs associated with use or redemption of prize is solely the winner's responsibility.
